# SESSION FOUR: President's, Directors', Region Representatives' and Staff's Reports 4.1- Director's Report

Ramon Zavala stated the region representative met on 11/20/15 and discussed reaching out to the chapters to turn in financials so they can get their rebates. Regina Piper stated the regional conference was very successful. Olivia Yahya stated that Whittier chapter is really taking the Project 2 Inspire to a higher level of involvement. Olivia Yahya stated that Pepperdine chapter is re-energizes their chapter. Long Beach chapter is having a fund raising on December 4, 2015. Sally Fox stated on November 1, 2015 the Palm Springs chapter had a Dia de Los Muertos event in which they collaborated with the City of Desert Palm Springs. The mayor was very complimentary. There were about 15 people were there at the event. S. Fox stated that next week the South San Diego chapter annual conference fund raiser for scholarship. They earned \$12,000 to \$15,000 for scholarships. Ana Donovan stated she attended the Ventura chapter 48 conference in September. A. ## 4.3 - Legislative Report

Martha Zaragoza-Diaz stated on December 1, 2015 the State Senate will met and the subject was Biliteracy and Effective Learning Strategies in Internationalized California. Martha Zaragoza-Diaz stated that the EdGe Campaign is putting together Executive Committee and Advisory Committee. Martha Zaragoza-Diaz stated on November 4, 2015, the State Board of Education approved instructional materials for kindergarten through grade eight. These instructional materials are aligned to the California Standards for English Language Arts & Literacy in Science, History-Social Studies and Technical subjects based on the Common Core and the California & English Language Development Standards. Martha Zaragoza-Diaz stated the field test version of the eTemplate was released on June 2, 2015, and the anticipated full release of the eTemplate will be February 1, 2016, in time to be used by any interested LEA for the development of their 2016-17 LCAP.

**Presentation-** Jannelle Kubinec, West Ed (via Skype) presented the LCFF evaluation rubrics: 1) To assist local education agencies to identify strengths, weaknesses, and areas that require improvement. 2) To assist County Offices of Education to identify school districts and charter schools in need of technical

assistance 3) To assist the State Superintendent in identifying school districts for which intervention is warranted 4) To reflect a holistic, multidimensional assessment of school district and individual school site performance and include all of the state priorities 5) To include standards for school district and individual school site performance and expectation for improvement in regard to each of the state priorities.

Presentation-Jesse Melgar presented the background and information on the California Ed.G.E Initiative (Education for Global Economy). The initiative still does not have an initiative number or written by the Attorney General. Polling on the initiative will be conducted in early 2016. Opinion research for ballot arguments will be done sometime in May/June 2016. Fundraising goals are: \$200,000 in 2015 and \$6 million in 2016. Two campaign committees are being established: Executive Committee (primarily responsible for fundraising and executive decisions) and Steering Committee (providing support in campaign implementation).
