Rosalinda Quintanar stated that CTA is supporting the following legislature: Assembly Bill 1505 (O'Donnell) would ensure that decisions regarding authorization and renewal of charters are made at the local level. Assembly Bill 1506 (McCarty) would put a cap on the growth of charter schools and stem the disruption and financial hardship to neighborhood schools and their students caused by the rapid growth of charters. Assembly Bill 1507 (Smith) closes a loophole that allows charters to operate schools outside of their authorizing district. Assembly Bill 1508 (Bonta) allows authorizers to consider fiscal, academic and facilities-related impacts on existing district schools when considering new charter petitions.

#### 3.1 – CABE 2019 Attendance and Financial Update

Yvette Chong-Coontz stated that to date we have 5,500 paid registrations for CABE 2019. This is not counting the people that will register onsite. Yvette stated the Audit Committee approved the 990 and a 990-T-The Exempt Organization Business Income Tax Form for *Employee Parking Fringe Benefits*.

## 3.2 - CABE 2019 Overview and Schedule

Delma Chwilinski stated that there is a CABE App is now available. Jan Corea shared information on the Board Awardees, special receptions, key partners, and sponsors. Jan Corea shared that Ginger Collier and Wayne Thomas will be having special meetings during the conference.

#### 3.3 – Legislative Report

Martha Zaragoza-Diaz stated that now that Governor Newsom is elected, a democratic supermajority exists in both houses of the California Legislature and Assembly Member Tony Thurmond is the newly elected State Superintendent of Public Instruction. Jennifer Johnson remains as Legislative Deputy Secretary for K-12 public education. She is very knowledgeable on English Learner issues. Martha stated that the state will be recruiting for the Performance, Planning and Technology Branch as Tom Adams will be retiring effective July 1. Linda Darling Hammond was appointed as a

State Board of Education member. Martha recommended that CABE have a Capitol Day for members to visit the state legislatures in Sacramento.

#### 3.4 – Mexican Relationship Update

Enrique González stated that Jan, Elodia, and Amparo López López went to México to meet with the new administration. The visit was to get to know the new members of the administration and to talk about CABE was about and the past partnership with México. The new director of IME is Roberto Valdovinos will be here at the conference as well as Benito Mirón, Director General de Politicas Públicas, Secretaria de Gobernación. There will be a reception for the delegates on Wednesday, 3/20 at 9:00 p.m.
