The goal of these programs is to promote biliteracy in English and another language such as Spanish, Vietnamese, Korean, Chinese and/or other languages.

Over 73% of the voters in California voted YES on Prop 58! Prop 58 provides the option to offer multilingual programs in our schools demonstrating the importance that being bilingual and biliterate has in our state, our nation and world!

If 20 parents per grade level or 30 parents per school site request (in writing or verbally) that they would like their child to be in a multilingual program, the school, district or county office education must acknowledge and consider the request³, and:

- Provide written notification of requests within 10 days.
- Conduct an analysis on models, costs and needed resources.
- Determine if the request is feasible and able to be implemented and provide notification within 60 days.
 - If the response is **YES**, a timeline and work plan need to be developed.
 - If the response is **NO**, a written explanation must be issued to those who made the request.
- **If you do not agree with the decision**, you can take local steps, continue conversations with district leaders and school board members or use the Uniform Complaint Process (UCP).
